- 5. The Research Analyst Entity has w.e.f September 1, 2025 appointed a Principal Officer thereby complying with the regulation specified under SEBI (Research Analysts) Regulations, 2014 Regulation 2(oa) read with 7(3), which requires the appointment of a Principal Officer with NISM certificate under this regulation. Based on the information made available to us, the entity did not appoint a Principal Officer with NISM certificate as required under the regulation during the audit period.
